

Club 163 former Martins staff had registered their interest in attending the Liverpool Lunch and 109 the London Lunch for which final reservation requests will accompany the late summer Newsletter.

#### **CHAIRMAN'S REPORT:**

Bernard Lovewell thanked his fellow committee colleagues for their efforts during the past 12 months; Arthur Rowe for his suggestion of the Union Jack Club for the December lunch, and especially for obtaining a discounted rate for this year's event: Alistair and Janet McIntosh for organising the Spring Lunch and finally Ken Quirk for organising last year's December Lunch and this year's London and Liverpool Lunches. Bernard continued by paying tribute to Colin Redshaw's time as our Treasurer when he stood-in on a temporary basis to ensure that Club continued to function.

#### TREASURER'S REPORT:

Colin Redshaw reported that our account balance was better by over £2.000 as a result of not having to subsidise the Thames Cruise and that the subsidy obtained by our secretary for the forthcoming December Lunches was also a welcome boost. Colin mentioned that the combination of these two factors had resulted in our balances being at their highest level for years and thanked Bill Steele for examining the accounts. Finally, Colin confirmed that nineteen new members had been recruited during the year.

#### **WELFARE OFFICER'S REPORT:**

Sue Sutcliffe reported that there had been no welfare issues during the year and that she had therefore nothing to report.

#### **ELECTION OF OFFICERS:**

Following Colin Redshaw's decision to stand down from the role of Treasurer (which he had taken on a 'temporary basis') Robert Bunn offered to become our Treasurer.

As the remaining Officers had agreed to remain in their roles their appointment was agreed unanimously.

#### **ELECTION OF AUDITOR:**

As Robert Bunn lives in north London, it was agreed that it would be left to Robert to find a suitable person to act as auditor in his local area.

#### ANY OTHER BUSINESS:

A general discussion followed about the problems experienced by the widows of former Martins staff when Willis Towers Watson's staff cannot understand the benefits provided by our Widows & Orphans Fund. Our secretary was asked to highlight this matter in the forthcoming Newsletter and ask everyone to bring it to the attention of widows in particular.

Note re 2019 Accounts: In early 2019, I wrote to the Pensions Administrators requesting support of £20 per head for our 50th Anniversary 'Remembrance' Lunches, to cover those ex-Martins staff who wished to attend but were not members of the Club, so that our funds would not be depleted by virtue of subsidising their lunches. Instead, we were provided with a one-off grant of £2,500 which was an excellent gesture by Barclays.

#### SECRETARY'S REPORT:

May I add (to Robert Bunn's report) that there was a further bonus in that in addition to our 'Remembrance Lunches' being extremely well-attended, more members were recruited, which further benefitted the finances of our Club. Our thanks go to everyone for your continued and future support.

I would also like to express my appreciation to members who have thanked me for producing our Newsletters, which I couldn't have done without our members' memories. Please keep them coming as our Newsletter, being part of our website, continues to be archived by The British Library for future generations.

One Final Request: We have also recently received donated memorabilia from Ann Ashcroft, which have been gratefully received by Jonathan Snowden for his Archive. Should you have any Martins memorabilia in your possession and don't know what to do with it then please feel free to contact me or Jonathan Snowden with details of what you have and we will see what can be done to preserve them.

#### WELFARE OFFICER'S REPORT:

**Sue Sutcliffe** confirms that she has not received any requests from any of our members.

## PROPOSED CHANGES TO OUR CONSTITUTION:

I have only been able to find a copy of our Constitution dated 10<sup>th</sup> September 1990 with several amendments attached and which needs to be updated to regularise the situation which has existed for several years. Consequently,

your Committee is proposing that the wording of our Constitution be amended as follows:

That our Annual General Meeting be held within 6 months of the end of our Financial Year.

AND: The reference to 'Auditor(s)' be amended to 'Honorary Examiner' and the number be reduced from two members to one third party member of the Club or a Barclays Pensioners' Club.

AND: Revise the reference to 'Four Officers' 'the two Committee Members and the two Auditors' to: Elect or re-elect the Chairman, Treasurer, Secretary and Welfare Officer and appoint one Honorary Examiner'

AND: Amend 'The Officers of the Club shall be Chairman, Vice Chairman, Treasurer and Secretary' to Chairman, Treasurer, Secretary and Welfare Officer.

AND: Re Membership; Amend 'former part-time staff...without pensions but with at least 20 years' service on the same terms as (full time staff)'. Delete the reference to 20 years' service. REASON: In all instances; as stated, the proposed amendments are simply in order to regularise the situation which has grown and existed for several years: Traditionally, our AGMs have been held in May despite our Constitution stating that the AGM should be held within 3 months of the end of our Financial Year. Our current Constitution states: The Club shall be audited annually by two members who shall have been elected for that purpose.

If approved by 'not less than two-thirds of those members present at the Annual General Meeting (as required by the Constitution) a revised Constitution will be produced and circulated to all members in a future 2022 Newsletter.

#### SPEND, SPEND, SPEND

The article in the Spring edition of the Newsletter triggered a memory which resulted in the following email from Rodger Scott, who writes: I joined the bank at 28/30 Park Row Leeds in September 1960 and I read, with interest, Stephen Lane's reference to his Dad's involvement with pools' winners via the Martins Bank Executor and Trustee Department (Christmas 2021 Newsletter). I can add a bit of flesh to the bones of his story.

There was such an office on the top floor of 28/30, served by both a staircase and a manual lift. Examateur boxer Albert Cooper, who, when he could, always seemed to be shadow boxing in the mirrors of the lift, was the lift driver, relieved by one of the messengers to cover his lunchtime or by one of us from the Junior Desk if no messenger was available.

About a year after I had started work, (just after 30 September 1961 to be precise) it fell to me, a mere 17-year-old, to take charge of the lift so that Albert could eat. It was a tricky job; the only control was a wonderfully polished, brass handle on the inside of the lift - push forward to go up, pull backwards to go down. What's tricky about that? Well, it was something of a work of art to gauge when to move to the central position for "Stop" to avoid having to ask passengers to "Mind the step" as the concertina gates were hauled back! If the step was too high or low a sharp tap of the controller would get us nearer our destination with a bit of a well-sprung jerk and an earlier warning of "Hold tight"!

On this particular lunchtime, three people entered the lift and asked for the Executor and Trustee Department: I duly delivered them, they minded the step and, as they left the lift, one of the male passengers slipped me half-a-crown for my services! My salary in those days was something like £24 a month so 2s6d was a lot of money!

It turned out that one of the men was from Littlewoods Pools, the other was Keith Nicholson and the lady was Viv Nicholson, his wife. Keith was my benefactor! They lived in Castleford and pools' winners without a bank account were invited by Littlewoods to be taken to their local Martins for investment advice. I read that the £152,319 which the Nicholson's win, was the equivalent of £3.36m in today's money!

It's sad that their win did not bring them lifelong happiness; Keith was killed in his car in 1965 on the A1 returning from racing and Viv died in 2015, the two of them having: "Spent, Spent and Spent"

Was the problem that troubled Colin Skelton's son. That was until, as an antiques dealer, he was visiting Newark's Antiques Fair last year and saw something that he immediately had to buy. Colin was well known in Martins 'AmDram' circles and featured in numerous productions, including, as the war-crippled grandson of the old landlord, in love with the old man's niece, played by Barbara Phillips, gave us a



join a small branch after six years at St. James's Street I went on relief, this was good practice for me as one of my regular duties was to



run Kew Bridge Sub Branch, which opened once a week for the benefit of the British Wool Marketing Board. It was here that I could practise my cricket with my compatriot, a ruler for a bat and a rubber for a ball and perhaps this



enabled me to be selected for the London District cricket team a couple of times. The other duty was to go to the pub next door

at opening time to buy two bottles of light ale and return them to the night safe to keep cool for lunch. We were lucky to see more than two customers in the day.

Those were the days!

has been replaced with the **Martins Bank Limited** sign above the door and window.

Above the door and window, little else has changed over the years.



We now move forward to 2014 and a photograph from a **facebook** 'post', where it would appear that our former sub-branch was in the process of being renovated.

year, it would appear that the transformation of our former Dent sub-branch has been completed ( left):

Many years ago, this property was the bank and in more recent years was a gallery with living accommodation above. permission. The retail space could also be sublet. The remainder of the property, whilst in need of renovation consists of an entrance hall, ground floor bathroom and first floor living room, kitchen and two bedrooms. The perfect property for a cottage industry in a charming Dales village.

#### OUR VICAR LANE BRANCH TODAY



Earlier this month my wife and I were in Leeds



and I took some photographs of our Vicar Lane branch. This image (above) is from 'Google Maps' which shows the three former bank buildings that still stand on the crossroads in Leeds of Vicar Lane and The Headrow, all of

which were built to the same design in the late 1930s. Our branch is on the left, Lloyds is on the right and Barclays is in the background on the right. The images are a clear illustration of how little our branch has changed over the past 80 years,



with only one of the original entrances having been blocked and replaced with a window. Our second Coat of Arms on the building, above one of the original doors, but now a window, ensures that we will never be forgotten. But, reverting to the first image of the three banks (Martins, Lloyds and Barclays): Although I had never thought about their design before, I realised that all of the buildings must have been designed by the same architect as part of the original 'Headrow' development, with each of their respective Coat of Arms being resplendent above their entrances.







I hope that this article resolves any mystery about the design of our former Vicar Lane branch.

#### WELLINGBOROUGH BRANCH

Memories were triggered by mention of Wellingborough branch in a recent Newsletter as David Ashby writes: I have noticed that you have visited Wellingborough and looked to see where the branch used to be.

At that time of opening, I was at Northampton Branch, with Wellingborough being one of our sub-branches, along with Kettering and Northampton Cattle Market. I had the pleasure of going over to Wellingborough as Clerk in Charge from time to time when holidays were taken.

I recognise the faces in the photo including my manager R M Whitlock and Colin York who is still a friend today. After a tour of Lincolnshire and Peterborough I returned to Wellingborough towards the end of my banking career. The Martins branch had been taken over by Yorkshire Bank. The final banking connection ended by closure on 13th June 2017.

Coincidently, **Mary Robinson** was my accountant at my last Barclays branch at Northampton-Wellingborough Road in 1994.

The following comments and images are from our website with the first being from the

are Mr P Boulton (who is Clerk in Charge of the new branch), Mr R M Whitlock manager of Northampton Branch, Mr W Turnbull Midland District General manager, Mr S C Allen, and Mr C York. On the Wellingborough page, Jonathan comments: We are indebted to Mary Robinson, who is featured here at the celebration party for the opening of

Martins Bank's new Wellingborough Branch in August 1967. One of the last of the new generation of the Bank's Branches to open, Wellingborough joins the Branch Network at a time when adding more and more offices is still seen as the answer to increasing business and profitability. Typical of most branch openings of the time, a cocktail party is held in celebration, and as a vehicle to court prospective customers to leave their existing banks.

It was also typical to invite local dignitaries, including: Mr C Forster (Chairman of Wellingborough Urban District Council), Mr B A J Taylor, (Chairman of Wellingborough Rural Council) and Mr R H S Greenwood, (Chairman, Rushden Urban Council) who represented another aspect of life in 1967 since which, like our existence, have disappeared following the Local Government reorganisation of 1974.



when it agreed to merge with the Burnley Building Society changed its name to the National and Provincial Building Society as the National Westminster Bank had retained the National Provincial name.




for the cheque number and branch Sort Code.

# THE GRASSHOPPER PENSIONERS' CLUB ACCOUNTS FOR THE YEAR ENDED 31 DECEMBER 2021

First thing to say is those of you who have attended AGMs' in the past will notice a change of style. This has come about following a comment at the AGM in 2019 concerning the omission of the Bank account and

also, to address notes which had been made by previous Account Examiners relating to marked fluctuations in postal costs. This was the result of postage stamps being purchased in advance of price increases and the stock not being shown. Additionally, we are now having to pay deposits when booking some venues so they also need to be shown in the accounts.

As we all know 2019 was the 50<sup>th</sup> anniversary of Barclays acquisition of our Bank and lunches were held all over the country with many former colleagues joining the Grasshoppers and attending an event for the first time. A special grant of £2,500 had been obtained to help defray the costs. The greatly enhanced attendance figure for 2019 events boosted the Social grant for 2020 and the same figure was used again as a basis for the grant in 2021 because of Covid restrictions. All the Bank grants are now administered through one account.

Generally, I have tried to give more detail without over complicating the figures so hope all is clear and easily understood. In the 2021 accounts the number of attendees is given, members and guests, and this clearly shows Martins' roots in the north of the country, and the higher costs of events in London.

Turning to Expenses, postage costs have been contained by using the services of a good friend of the Club Secretary who kindly franks the 230+ newsletters sent by post at a considerable saving as against affixing a stamp, standard letter with stamp, 66pence, franked, 47pence and large letter, £1.29/96pence. Newsletters keep the members informed, and hopefully, entertained. Over half the membership receive hard copies, printed on good quality paper and in colour. Fortunately, our Secretary has negotiated a good deal for us on the printing of the five newsletters produced annually.

Because of the very high number of members we receive a substantial Administration grant but once again costs have been kept to a minimum. Although a committee member, often more than one, will travel to attend the lunches held around the country no one claims any expenses. Consequently, the grant taken together with the Welfare grant, more than covers all the expenses notwithstanding the considerable monies spent on newsletters.

As mentioned previously, we were fortunate with the amount of the Social grant received the last two years so we go forward with a substantial balance, hopefully, to support events up and down the country when we will be able to properly enjoy the company of our former colleagues.
